Mr. Horn then introduced four Seniors who have been awarded Scholarships to different colleges, Marica Boster, Kyle Koprowitz, Abby Yemm, and Kevin Loveless. Each student introduced themselves and stated the scholarships which they have been awarded.
Mr. Downs then welcomed both the high school girls and boys basketball teams and recognized them for successful seasons this winter. He also mentioned other sports and their accomplishments for this year.

## 3. Communications

3.1 Comments from visitors

David Spann stated that school districts can not depend upon the State for financing; we need new ideas to raise money. We need to contact our legislators and let them know we want them to support the schools. Connie Schroeder asked about the Masonic Lodge Agreement. She was told that FFA was going to plant sweet corn to sell and $20 \%$ of the profit would go to the Masonic Lodge.
Mike Hemann asked about the committee to look into the Attendance Center implementation. He was told that the survey went out today to elementary parents and are due back next Friday at which time a committee will be formed. Tacy Greff asked if the committee was only to study attendance centers. Ron Ochu wanted to know who determines who will be on committee. Marica said the committee was only for the Attendance Center review and that the all parents interested can't be on the committee because it would be too large. The committee is to be two board members, two administrators, two parents from each elementary school, two community members and the superintendent. Mike Hemann wanted to know which board members would be on the committee. Because of the election members have not been picked for committee. Kim Eldridge wanted to know if the superintendent would be on the committee. Marica said she would be there to get it started but not to lead the committee. Jackie Meyers said we need true community involvement so we need to get it put on the internet and in the paper possibly even a skylert.
Rick Maguire asked if the teachers and administrators would be willing to give back $2 \%$ if community is willing to have taxes increased by $2 \%$, would that be enough money. Stacy Hughes would give $2 \%$ but wants to know what would be done with money. Is there a plan?
Several questions were posed regarding attendance centers, combined grades, and if finances are what prompted the discussion on attendance centers.

Farley Cole stated he has always felt attendance centers would be best for the district academically and financially.
Andrea Christopher had a question about combined classes; if $3^{\text {rd }}$ and $4^{\text {th }}$ graders were together would they both be $5^{\text {th }}$ graders the next year. The answer was no, two programs would be ran in the classroom and children would advance as normal.
Deb Butler wanted to know if Working Cash had gone through if fewer reductions would have been possible.
Rick Maguire brought up the Tax Anticipation Warrants. Marica said they do not really solve the problem but in the end makes it worse.
Furman said banks really not wanting to loan money to any Illinois School Districts. Marica said state is cutting funds and adding legislation that cost the schools more.
Deb Gripp shared concerns about combining 2nd and 3rd graders being a bad idea, because it would be hard on teachers and students. Marica stated that her daughter was in a $2^{\text {nd }}$ and $3^{\text {rd }}$ grade split for two years and how she really benefited from the experience. Robyn Hays said she has taught successfully in the same situation. Further, Mrs. Bitner also would provide support for teacher and student.
Kim Eldridge inquired about opening registration in June. Marica said school would take money all summer long but official registration would not be in June. Registration fees would be posted on the website.
