- 2.2 President's Remarks Cole stated the meeting was to discuss and vote on the Collective Bargaining Agreement
- 3. Continuing Business
  - 3.1 North Mac CUSD #34 and North Mac Education Association Collective Bargaining Agreement Motion was made by Nichols, seconded by Alexander to approve the negotiated 2013-2017 Collective Bargaining Agreement recommended by the Members of the Negotiations Committee. Yea votes Spann, Alexander, Handy, Nichols, Cole
  - 3.2 Long Range Survey Plan and Evaluation Motion was made by Nichols, seconded by Handy to hire EvalSolutions to conduct a staff survey and present findings to the Board.

A general discussion was held, Handy stated the reason initially for the survey was due to the fact the staff was not happy and board had thought the survey would help with communication. Spann talked about chain of command and Hays thought it would be a good avenue to state concerns. Farley brought up the fact of all the changes that had occurred at the first of the year. Lots of changes cause emotions to run high. Faculty wanted to be more involved in Attendance Center decisions.

Hays feels survey with open ended questions better because it is a positive way to address change. Survey will help board see if timelines have been too short.
