- 1. The Regular Board of Education meeting was called to order at 6:30 p.m. by President Robyn Hays.
- 2. Pledge of Allegiance was led by Robyn Hays

- 3. Public Comments Rev. R. T. Holt introduced himself as the Pastor at the Trinity Lutheran Church. He had a few questions regarding the Baccalaureate Service which will be held at the Trinity Lutheran Church this year. He inquired how many seniors were this year, number normally in attendance for students, faculty and board members. Mr. Horn informed him there are 92 seniors usually 15 to 20 will attend, a few faculty and 3 Board Members attended last year. He asked if he could have addresses to mail invitations to the senior class and also if he could ask them to sing in the choir during the service. Rev. Holt said he had not expectations that the students wear their caps and gowns, just to come as they are would be great.

- 5. Student Success Story Mr. Cooper introduced his Science Olympiad Students to the Board. He explained how they attend one invite and then go to Regionals. There are 23 events the students can participate in, some are events are with partners and others are in teams. Several of the students explained what their projects. Some are experiments and others are study guides. A couple of students had papers that were over 500 pages long. He explained how they meet twice a week and have been since October.
- 6. School Improvement & Leadership Reports/Questions
 - 6.1 Mrs. Cimarossa Oral Report Mrs. Cimarossa reported on the different types of testing that have been occurring at the Intermediate School. She passed out a couple of handouts which showed how the students have improved test scores since first tested at the beginning of the year.

- 6.2 Questions for Mrs. Bitner Worth asked Mrs. Bitner about the predicted retentions for this year. The majority of the students are in kindergarten and studies have shown that retentions in kindergarten and first grade benefit students more than retentions in later years. Mrs. Bitner also explained that Pre K enrollment is still very low for next year.
- 6.3 Questions for Mr. McMillin Cole asked about the school promotion that was discussed at the April 19th meeting. Mr. McMillin explained it was in reference to pictures and banners which reflect the achievements of the students in the Middle School. Worth also asked about the attendance issue at the Middle School. McMillin explained that is kind of crept up on them, they have involved parents, police and ROE. Several factors come into play such as the homeless rate being higher and students moving in and out of the district.
- 6.4 Questions for Mr. Horn Nichols asked about the "Flipped Classroom" being done in Mrs. Gillespie's room. Mr. Horn explained that she records her lecture and posts it on YouTube, the students then watch it. That way they can do their assignment during class and have Mrs. Gillespie to help.
- 6.5 Questions for Mr. Downs Mr. Downs told the board that at the County Meet both the 8th grade boys and girls received First place. After Coach Allen reviewed the scores the next day he discovered that North Mac girls had not placed first, they had actually received 2nd by 1 point. Staunton should have been first. Coach Allen notified Mr. Downs of the error and immediately they notified Staunton of the error. Mr. Downs also contacted IESA of what Coach Allen had done and IESA posted on their website the good sportsmanship showed by Coach Allen.
